On 31 May 2018, Prosper One International Holdings Company Limited (the “Company”) and Macquarie Bank Limited (the “Subscriber”) entered into a conditional subscription agreement (the “Subscription Agreement”), pursuant to which the Company had conditionally agreed to issue, and the Subscriber had conditionally agreed to subscribe for, the 0.8% convertible notes (the “Notes”) in principal amount of up to HK\$80,000,000 under a specific mandate (to be sought from shareholders of the Company). The maximum total number of ordinary shares to be issued pursuant to the exercise of conversion rights attached to the Notes shall be 100,000,000, subject to adjustment. On 20 June 2018, the Company and the Subscriber entered into an amendment agreement, pursuant to which the Company and the Subscriber agreed to change the deadline for the closing date and the date for the satisfaction of the conditions precedent as set out in the Subscription Agreement to 31 July 2018. Please refer to the Company’s announcements dated 31 May 2018 and 20 June 2018 for details.
