Remarks (if any):

On 31 May 2018, Prosper One International Holdings Company Limited (the “Company”) and Macquarie Bank Limited (the “Subscriber”) entered into a conditional subscription agreement (the “Subscription Agreement”), pursuant to which the Company had conditionally agreed to issue, and the Subscriber had conditionally agreed to subscribe for, the 0.8% convertible notes (the “Notes”) in principal amount of up to HK\$80,000,000 under a specific mandate (to be sought from shareholders of the Company). The maximum total number of ordinary shares to be issued pursuant to the exercise of conversion rights attached to the Notes shall be 100,000,000, subject to adjustment. On 20 June 2018, the Company and the Subscriber entered into an amendment agreement, pursuant to which the Company and the Subscriber agreed to change the deadline for the closing date and the date for the satisfaction of the conditions precedent as set out in the Subscription Agreement to 31 July 2018. On 4 July 2018, the Company and the Subscriber entered into a second amendment agreement (the “Second Amendment Agreement”), pursuant to which the Company and the Subscriber agreed to delete in its entirety a clause in the Subscription Agreement in respect of an adjustment to the minimum conversion price (i.e. HK\$0.80 each subject to adjustments) determined by the Company or a holder of the Notes. On 26 July 2018, the Company passed an ordinary resolution which generally and unconditionally approved, ratified and confirmed the Subscription Agreement and the Second Amendment Agreement entered into between the Company and the Subscriber. All the conditions precedent set out in the Subscription Agreement had been fulfilled and completion of issue of the first tranche of the Notes to the Subscriber in the principle amount of HK\$40,000,000 took place on 31 July 2018. Please refer to the announcements of the Company dated 31 May, 20 June, 29 June, 4 July, 26 July and 31 July 2018 and its circular dated 11 July 2018 for details.
